### Introduction:

This Assessment Venue Application form must be completed by the National Governing Body seeking to undertake international accreditation at their event.

In order for an event to be considered it shall:

1. A completed application must be submitted to the Officiating Chair according to the timelines below.

<b>New event / venue</b>	Application must be received not less than <b>four months</b> prior to the commencement of the proposed event
<b>Previously approved events / venues</b>	Application must be received not less than <b>three months</b> prior to the commencement of the proposed event.

2. For new International Official applicants, the length of the assessment period must be no less than three days of competition and for renewals not less than two days of competition. **N.B. Officials must be seen on a minimum of one game each day.**
3. The FIL assessors must be approved by the FIL Sector Officiating chair in accordance to the FIL Accreditation policy. **N.B. Assessors must be available for the whole length of the event.**

This application shall be submitted in conjunction with the Candidate and Assessor Conflict of Interest form and all candidates officiating resumes/curriculum vitae for the past three years.

Upon submission of this form, the information will be reviewed, after which the individuals/organisers of the accreditation will be advised if the venue has been deemed suitable for assessment.

Where the application does not meet an element of the above criteria, the Officiating Chair and Sector Director shall have the discretion to review the application and approve as necessary.
